#### **RE: Value Added Tax (VAT) & New Customs Regulations**

Please be advised that ZipX Bahamas Limited is duly registered under the Value Added Tax Act 2014 and is thus mandated to charge and collect VAT on behalf of the Government of the Bahamas. Our Tax Identification Number (TIN) is 100402492.

The VAT rate of 7.5% will be added to all ZipX Services, including but not limited to:

- Purchasing
- Pick-ups
- · Air freight
- Brokerage
- Customs Duty/Excise Tax/Processing fees
- Delivery
- Transshipment within The Bahamas
- Credit card fees

As a result of changes with Bahamas Customs relating to VAT each customer will be given a separate duty receipt so consolidation of customers' goods to process on one entry is no longer allowed, i.e. invoices in separate names will require separate entries and therefore pay a separate brokerage fee.

In lieu of this, if you wish consolidation make sure the customer name is exactly the same on each invoice. We encourage consolidation for cost savings to you our valued customers. Please be advised we will limit consolidation to 14 days and there will be no consolidation in the month of December.

Upon implementation of this new tax regime, we will be enforcing strict compliance in our accounts receivables collections. Therefore effective January 1st the following procedures will be in place for all ZipX customers:

- All past due (2014) invoices must be paid by January 5th, 2015
- 2015 invoices will be due and payable 3 days after the invoice is presented to you
- Any invoice that is overdue will cause your account to be placed on hold and air freight will be suspended until such time that the account has become regularized

We thank you for your patience as we transition to VAT and assure each of you of our commitment to providing you with consistent and reliable service, and thank you for your loyalty and patronage of ZipX Bahamas!
